SOUTH AUSTRALIA Proclamation by His Excellency the Governor of the State of South Australia

D. B. DUNSTAN

PURSUANT to the Crown Lands Act, 1929-1983, and all other powers, I, the Governor, with the advice and consent of the Executive Council:

- 1. Diminish the area of the Town of Lock by removing therefrom the lands defined in The First Schedule.
- 2. Extend the area of the Town of Lock by adding thereto the lands defined in The Second Schedule.
- 3. Resume the lands defined in The Third Schedule.
- 4. Dedicate the Crown lands defined in The Fourth Schedule as park lands and declare that such lands shall be under the care, control and management of the District Council of Elliston.
- 5. Reserve the Crown lands defined in The Fifth Schedule as an aged persons accommodation reserve and declare that such lands shall be under the care, control and management of the District Council of Elliston.

THE FIRST SCHEDULE

That portion of the Town of Lock, Hundred of McLachlan, County of Musgrave, the proclamation of which was published in the Government Gazette of 7 March 1918, at pages 441 and 442 and amended by proclamations published in the Government Gazette of 27 October 1960, at page 1125 and 2 December 1982, at page 1746, bounded as follows:

Commencing at the south-western corner of allotment 126; thence westerly along the production westerly of the southern boundary of said allotment to its intersection with the production

southerly of the western boundary of Terre Street; northerly along latter production to its intersection with the production westerly of the northern boundary of aforesaid allotment 126; easterly along latter production; thence south-westerly and southerly along north-western and western boundaries of said allotment to the point of commencement.

THE SECOND SCHEDULE

Those portions of the Hundred of McLachlan, County of Musgrave, bounded as follows:

- (1) Commencing at the south-western corner of section 115; thence easterly along portion of the southern boundary of said section to its intersection with the production northerly of the eastern boundary of allotment 137, Town of Lock; southerly along portion of latter production to its intersection with the production easterly of the northern boundary of said allotment; westerly along latter production and boundary and the northern boundaries of allotments 136, 135 and 134, Town of Lock and production to its intersection with the production southerly of the western boundary of section 115 aforesaid; thence northerly along latter production to the point of commencement.
- (2) Commencing at the north-western corner of section 131; thence northerly by the production northerly of the western boundary of said section to its intersection with the production westerly of the southern boundary of allotment 145, Town of Lock; easterly along latter production and boundary and the southern boundaries of allotments 144, 143 and 142, Town of Lock and production to its intersection with the production northerly of the eastern boundary of section 131 aforesaid; southerly along latter production to the north-eastern corner of said section; thence westerly along the northern boundary of the aforesaid section to the point of commencement.

THE THIRD SCHEDULE

Park lands, sections 115, 121 and 131, adjacent to the Town of Lock, Hundred of McLachlan, County of Musgrave, the proclamation of which was published in the *Government Gazette* of 25 March 1982, at page 863.

THE FOURTH SCHEDULE

Sections 115 and 121, adjacent to the Town of Lock, Hundred of McLachlan, County of Musgrave, exclusive of all necessary roads, being the greater portion of the land defined in The Third Schedule hereto.

THE FIFTH SCHEDULE

Section 131, Hundred of McLachlan, County of Musgrave, exclusive of all necessary roads, being the remaining portion of the land defined in The Third Schedule hereto, together with other land and more particularly delineated on the Public Map of the said hundred deposited in the Department of Lands at Adelaide.
