BY virtue of the provisions of "The Crown Lands Act, 1903," I, the said Lieutenant-Governor, with the advice and consent of the Executive Council of the said State, do hereby dedicate the lands described in the schedule hereto as a reserve for school purposes, not intended for ecclesiastical or denominational purposes.

BY virtue of the provisions of "The Crown Lands Act, 1903," and "The District Councils Act, 1887," I, the said Lieutenant-Governor, with the advice and consent of the Executive Council of the said State, do hereby dedicate the lands described in the schedule hereto as a water reserve, and place the said reserve under the care, control, and management of the District Council of Elliston.

## LAND ACQUIRED UNDER "THE CLOSER SETTLEMENT ACTS, 1910 TO 1912."

## TOWNS OF BORRIKA AND LOWALDIE.

SOUTH AUSTRALIA, { *Proclamation by the Right Honorable Sir SAMUEL JAMES WAY, Baronet, Chief Justice, Lieutenant-Governor of the State of South Australia and its Dependencies in the Commonwealth of Australia.*  
to wit.

BY virtue of the provisions of "The Crown Lands Act, 1903," I, the said Lieutenant-Governor, with the advice and consent of the Executive Council of the said State, do hereby—

1. Set apart the lands respectively mentioned in the schedule hereto as town lands.
2. Constitute the said lands new towns, to be called the towns of Borrika and Lowaldie, the boundaries whereof are respectively defined in the said schedule.
3. Direct that this proclamation shall take effect from the day of the publication thereof in the *Government Gazette*.

## THE SCHEDULE.

*Town of Borrika.*—Comprising that portion of the hundred of Wilson bounded as follows:—Commencing at a point being the intersection of the south-eastern side of the Borrika Railway Station Yard with the production north-westerly of the south-western side of road south-west of surveyed lot 1 (situate about 10 chains southerly from the centre of the Borrika Railway Station Yard aforesaid); thence south-easterly at right angles to said side of station yard for 1,425 links; thence north-easterly at right angles for 2,350 links; thence north-westerly at right angles for 1,425 links to the south-eastern side of station yard aforesaid; and thence south-westerly along said side of station yard for 2,350 links to the point of commencement.

*Town of Lowaldie.*—Comprising that portion of the hundred of Wilson bounded as follows:—Commencing at a point being the intersection of the south-western side of road south-west of surveyed lot 1 (situated about 12 chains southerly from the centre of the Lowaldie Station Yard) with the production south-westerly of the north-western side of road north-west of said lot; thence south-easterly along the south-western side of road south-west of lot 1 aforesaid for 1,425 links; thence

north-easterly at right angles for 2,350 links; thence north-westerly at right angles for 1,425 links; and thence south-westerly at right angles for 2,350 links to the point of commencement.
