

## CROWN LANDS ACT, 1929: SECTION 5

TAKE NOTICE that pursuant to the Crown Lands Act, 1929, I, SUSAN MARY LENEHAN, Minister of Lands and the Minister of the Crown to whom the administration of the Crown Lands Act, 1929 is committed DO HEREBY:

1. Diminish the area of the Town of Venus Bay by removing therefrom the lands defined in The First Schedule.
2. Declare that all the roads in the said Town of Venus Bay so being diminished, shall be closed, being:
  - (a) all that portion of Government Road dividing allotments 111, 113, 115, 117, 119, 121, 93 and 67 and allotment 3 (Filed Plan No. 6331) from section 39, Hundred of Wright,
  - (b) all that portion of Thomas Street dividing allotments 86, 112 and 113 from allotments 87, 114 and 115.
