MINING ACT, 1930-1962: HUNDRED OF HAINES AND SOUTH OUT OF HUNDREDS—LANDS RESERVED FROM THE OPERATION OF THE ACT.

SOUTH AUSTRALIA | Proclamation by His Excellency the Governor of the State of South Australia.

EDRIC BASTYAN. (L.S.)

BY virtue of the provisions of the Mining Act, 1930-1962, and all other enabling powers, I, the said Governor, with the advice and consent of the Executive Council, do hereby reserve the mineral lands defined in the schedule hereto from the operation of all the provisions of the said Act, except the provisions of section 20a of the said Act.

THE SCHEDULE

Those portions of the hundred of Haines and south out of hundreds bounded as follows:—Commencing at the northwestern corner of section 141, hundred of Haines; thence easterly along the northern boundaries of said section and sections 143 and T, and production to high water mark; northeasterly by a straight line at a north-western angle of 130° with latter boundary to intersect a line distant one mile from and parallel to high water mark; thence generally easterly following latter line to its intersection with the production northerly of the eastern boundary of section 217, hundred of Haines; southerly along latter production and boundary to the south-eastern corner of latter section; generally westerly along the southern boundaries of section 217 to its intersection with the production northerly of the eastern boundary of section the southern boundaries of section 217 to its intersection with the production northerly of the eastern boundary of section 216; southerly along the latter production and boundary and westerly along the southern boundary of latter section and section 215 and production to the eastern boundary of section 135; southerly along portion of latter boundary to the southeastern corner of said section; westerly along the southern boundary of section 135 aforesaid to its south-western corner; south-easterly along portion of the south-western boundary of section 134 to its intersection with the production easterly of the southern boundary of section 136; westerly along latter production and boundary and the southern boundaries of sections 137, 138, 140 and 147; northerly along the western boundary of said section 147 and production to its intersection with a south-eastern boundary of section 145; generally west-south-westerly along the south-eastern boundaries of sections 145 and 144 to the southernmost corner of latter section; north-145 and 144 to the southernmost corner of latter section; north-westerly along a south-western boundary of section 144 and generally westerly along a southern boundary of latter section

and the southern boundaries of section 149 to the western and the southern boundaries of section 125 to the western corner of latter section; south-westerly by a straight line to the eastern corner of section 141; westerly and northerly along the southern and western boundaries respectively of latter section to the point of commencement, crossing all intervening roads.
