Fire Prevention 2021

It's already that time of year with the fire season here. A wet winter has created a lot of growth and we all want everyone to be safe. Our district is no stranger to fires and summer months are of particular concern. Township property owners are reminded to make their properties fire safe, removing any fuel piles, long grass and cleaning out fire debris under trees. It is a requirement for allotments less than 0.5ha, that all fuel (grass & weeds) is cleared around houses and property to a maximum height of 10cm. For allotments greater than 0.5ha a 20m fuel reduction zone is required around homes and a 5m fuel reduction zone is required around sheds and other infrastructure as well as a property fire break of 4m around the boundaries. Head to the Council website for further fire prevention information, contact details of Fire Permit Officers and preparing for the fire danger season. Always have a plan in place should a fire occur. - Clean aluminium foil scrunched into a fist sized ball

Fight the Bite

Did you know rainwater tanks and septic tanks can be potential breeding sites for mosquitoes.

You can reduce the risk by:

- checking valves on rainwater tanks (particularly inground tanks) by making sure the valves are still in place and by making any necessary repairs.
- do not allow water to pool in containers below the outlet or taps.
- ensuring rainwater and septic tank openings, wells or other large water containers are covered with wire mesh no coarser than 1mm.

As a last resort, rainwater tanks can be treated by adding a small amount of liquid paraffin or domestic kerosene. Do not apply kerosene if water levels are low.

Add 5mL of kerosene (or 1 teaspoon) for a 1kL tank and up to 15mL or 3 teaspoons for a 10kL tank. When using paraffin, double the dose.

NOTE: Consult your rainwater tank manufacturer about whether kerosene can be used. Commercial or industrial kerosene, such as power kerosene for tractors, should not be used in rainwater tanks.

Dogs and cats

The new laws are to eliminate unscrupulous breeders from the industry. Anyone who breeds and/or trades in companion animals should follow the South Australian Standards and Guidelines for Breeding and Trading Companion Animals. These standards set minimum requirements for housing, husbandry, veterinary care and living conditions for breeding dogs and cats and their litters. All breeders must adhere to, or exceed, these standards to avoid breaking animal welfare laws.

All dogs, cats and breeders must be registered. If you wish to breed and sell animals, you must register yourself as a breeder on Dogs and Cats Online.

If you are a seller, any advertisement selling a dog or cat must include the following information:

- The seller's name and number
- The breeder's name and number
- The breeder's Dogs and Cats Online breeder registration number
- If more than one person was involved in the breeding, these details must appear for each person.

Breeders must have puppies/kittens microchipped before sale. Microchip numbers entered in Dogs and Cats Online must be transferred to the new owner:

- The microchip implanter will record the microchip number in Dogs and Cats Online to the owner/breeder.
- The breeder must transfer the microchip number to the buyer in Dogs and Cats Online and provide the owner the microchip number so they can complete the registration in Dogs and Cats Online.

Any person who sells a dog or cat must provide the following information to purchasers in writing.

The name, address and phone number of the seller;

The name, address, phone number and Dogs and Cats Online breeder number for each breeder involved;

Any vaccination, treatment or desexing details the animal has received and the name and address of the veterinarian;

The animal's microchip number; name and address of the microchip implanter; date of the procedure; and registries the microchip information is stored on;

Dogs and cats (cont.)

Any vet exemptions from microchipping or desexing; Details of any known illness or medical condition; Details of any (dog) control order in place.

All dogs and cats born after the 1 July 2018 must be desexed (some exemptions apply). Breeders who are registered in Dogs and Cats Online do not have to have their breeding animals desexed.

Dogs and cats must be desexed within 28 days of purchase and before 6 months of age. If a time extension is granted, the procedure must occur before the date specified in the extension.

You can find a Bushfire Safer Place in Elliston, Lock and Venus Bay. Please see back pages for maps.

Port Kenny has been designated with a Bushfire Last Resort Refuge. This is a LAST choice of location to shelter from bushfire. A Bushfire Last Resort Refuge is a space or building that provides a minimum level of protection from the immediate life threatening effects of radiant heat and direct flame contact in a bushfire. It is an area intended to provide a place of relative safety during a bushfire but does not guarantee the survival of those who assemble there. The Bushfire Last Resort Refuge in Port Kenny is the playground in town on Flinders Highway.

You should complete and practice your Bushfire Survival Plan to ensure that you and your family are prepared and know what to do in the event of a bushfire.




