We apologise for any inconvenience this may cause, but the safety of our District, staff and residents comes first.

JETTIES

Jetties are in the news as many of the state-divested jetties (of which the historic Elliston Jetty is one) are reaching end of life.

Jetties are an important part of our history, giving people a reason and a way to visit our coastal towns and to provide our community with easy access to the water.

Around 25 years ago, the state handed control to the Council for the Elliston Jetty. At that time, Council had no choice but to take on responsibility for maintenance of the jetty or else the jetty may have been closed.

Council is required to maintain the jetty and does allocate a budget each year for repairs and maintenance, but significant work will need to be undertaken soon.

The State Government, the 'landlord' of the jetty, is asking local councils to take on responsibility for ensuring jetties remain structurally sound. This is like a landlord asking a renter to fix the roof if it collapsed on a rental property.

The State Government has allocated \$20 million over 4 years to help repair all jetties across the state – around \$10 million for council-lease jetties. This is nowhere near enough, and to access that money, councils are being asked to bear future costs, long after the funding is exhausted.

For our District, this is not an option, and the financial exposure to the Council and community is too great. A better long-term answer is needed. Council, and the wider Local Government Association, are working together to ensure the State Government understands the value of our jetty to our community.

HIGHWAY COMPLAINTS

The Flinders Highway, Birdseye Highway and Tod Highway are the responsibility of the Department for Infrastructure and Transport (DIT), even though they pass through our Council area. Council has no jurisdiction over these roads.

Road and hazard faults on these Highways need to be reported to DIT's Traffic Management Centre on 1800 018 313.

You should report any hazards that present a risk to the safety of road users. Hazards may include:

- Debris on the road eg a fallen tree, gravel, glass
- The need for road maintenance
- · Damaged safety railing guardrails
- A dead animal causing a traffic hazard on a roadway



UPDATING SOUTH AUSTRALIA'S BUSHFIRE HAZARD MAPPING AND PLANNING RULES

Have your say on a proposal to update bushfire hazard mapping and effectively plan for and mitigate the impacts of bushfire hazards across South Australia.

The State-wide Bushfire Hazards Overlay Code Amendment is being undertaken by the State Planning Commission and seeks to update the spatial application of the bushfire hazard overlays to reflect recent bushfire hazard mapping, and review the policy contained in each of the overlays.

NBN IS COMING TO LOCK

The Council is pleased to announce that in conjunction with NBN co we have been successful in obtaining funding of \$1.32million to deliver fixed wireless broadband to Lock, providing improved connectivity. More details will follow soon.

CLOSING OF TELSTRA 3G NETWORK

From 30 June 2024 Telstra will be switching off it's 3G services. If you have a 3G only device you will be unable to connect to Telstra's network after they close this network. Also in order to make calls (including emergency calls) you will need Voice over LTE (VoLTE) on your 4G device as well. COMMUNITY SAFETY NEWS

FIRE PREVENTION

January rains have triggered regrowth of fuels around the District. This is widespread in some areas and is largely due to the frequency and amount of rain that has occurred. This has resulted in some areas having similar fuel conditions to autumn where we see germination and then greening.

It is important for property owners to remember that fire prevention maintenance may be required to be attended to again.

During summer maintain your preparedness through the Fire Danger Season:

- Maintain defendable space of up to 20 metres around your home (greater if on a slope) and 5 metres from sheds and garages.
- Clear around trees.
- Remove leaves from gutters.
- Slash stubble near sheds and buildings (following regulations for Total Fire Ban Days).
- Check reserve water supplies.
- Practise your Bushfire Survival Plan with your family.
- Ensure you have a portable battery-powered radio and spare batteries to listen to bushfire warnings.
- Monitor Fire Danger Ratings.



MOSQUITOES

Don't let mosquitoes bite into your holiday! In summer we love holidaying and being outside but it's also when mosquitoes breed and bite.

Protect your holiday houses, shacks, boats, caravans and tents:

- Mosquitoes breed in still water, fresh or salty water, and often in puddles and containers.
- Look for and reduce mosquito breeding sites around your holiday house, shack and caravan, or camping ground by emptying or covering anything that holds water.
- Make sure windows and openings are fitted with mosquito-proof mesh.
- Cover your sleeping areas or beds with mosquito nets if you don't have insect screens, or if you're camping outdoors near a creek, water hole, swamp, river or in long grass.
- Boats, canoes and dinghies should be stored so they don't hold water.

CATS AND DOGS



When our officers find dogs and cats (or one is handed in) they'll scan it for a microchip, then look up its record to get it back home with you. Your up-to-date details make this process smoother for you.

Did you know you can also add a temporary address on your account on https://dogsandcatsonline.com.au/. If you are holidaying with your pet or are having it looked after elsewhere, a temporary address and contact person can be recorded to your animal. It's easy! Just click on the animal's name on your account and scroll down to Location. Tick "Yes" to Temporary Location and fill in the required information and Save.

SHARK INCIDENT MITIGATION

As you are all aware, interactions with Great White Sharks have become more prevalent along the South Australian coastline in the last year.

Following the most recent attack in our District, the Council has advocated to the State Government for the following:

- 1. Increased tagging of Great White Sharks to ascertain additional information regarding shark movements through Australian waters
- 2.Installation of a network of monitoring buoys across the State's coastline, especially in regional and remote locations
- 3. Rollout of smart technology to allow information regarding shark movements near monitoring buoys to be made available to people considering entering, or already in, the water
- 4. Subsidisation of personal protection devices that are proven to assist with Great White Shark attacks
- 5. Investment in drone or alternative technology, that allows shark patrols to occur in remote areas
- 6. Establishment of a government body to oversee all aspects of shark management across the State
- 7. Improved reporting processes for commercial fishermen, ensuring impact-free reporting
- 8. Improved education to recreation fishermen regarding appropriate reporting of shark interactions through Fishwatch
- 9. Further research to be undertaken into water temperature fluctuations and the effect this has on shark movements

Additionally, Council is in the process of implementing the following:

- 1. Installation of Arterial Bleed First Aid Kits at strategic locations across our coastline
- 2. Increased signage at Boat Ramps and Jetties to remind fishermen to not clean fish out at sea or near these facilities
- 3.A Surfers First Aid Course

We have also sought financial support from the State Government for:

- 1. A swimming enclosure near the Elliston Jetty
- 2. Trauma and wellbeing support

The Council has also lodged a motion with the Eyre Peninsula Local Government Association to:

- 1. Ban the use of berley and teaser baits at Shark Cage Diving sites
- 2. Allow PIRSA to cull Great White Sharks for a 48 hour period after an attack

INFRASTRUCTURE NEWS

VENUS BAY

Resealing of Matson Terrace and the Boat Ramp Carpark have been completed.

Work on the installation of the BBQ shelter at the playground will commence shortly.

PORT KENNY

Fencing of the children's playground has commenced. Paving of the area next to the BBQ will occur when the fencing has been complete.

Screening of the public toilets has been finished. This will provide a level of privacy to people using these facilities which are visible from Flinders Highway.

LOCK

The Aquatic and Gym Complex is nearing completion with Council staff and the builder undertaking a full site and defect inspection at the end of January. Opening dates will be advised as soon as we know.

Council is also working on a solution to address short-term worker accommodation, desperately needed by the town during harvest.

SHERINGA

Roadside clearance is being undertaken to help driver visibility and for fire prevention.

ELLISTON

Pigeon control is an ongoing issue in Elliston, and contactors are being regularly engaged to assist with this issue.

Garden beds on the Esplanade and Beach Terrace are being cleared ready for replanting when the weather is appropriate.

Council has removed pieces of the playground equipment from Trudinger Park due to safety concerns. We are currently investigating options for their repair or replacement.
